4 FIRST-AID MEASURES

SPECIAL FIRE FIGHTING PROCEDURES

Fire will produce dense black smoke containing hazardous products of combustion (see Section 10). Exposure to decomposition products may be hazardous to health. 7 HANDLING AND STORAGE

USAGE PRECAUTIONS

A small quantity of an Organic Peroxide is supplied for use as an activator with the Filler. Refer to instructions and safety warnings given on the packs prior to using the product. Vapours are heavier than air and may spread along floors. They may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentrations higher than the occupational exposure limits. Keep away from heat, sparks and open flame. Non-sparking tools should be used. Smoking, eating and drinking should be prohibited in areas of storage and use. Avoid skin and eye contact. Avoid inhalation of vapour. Avoid inhalation of dust.

STORAGE PRECAUTIONS
